**Heather Lyall** - January 2018 The Air Institute hosted a summit to explore a new Appalachian creative economy network. Seven states have joined together to focus on growing our local creative economy. Being creative and making things is a deep part of our culture. Gardening, making quilts and canning our foods are art. This work will help raise the value of art and creativity in Dickenson County, Appalachia and within our youth. We use social media and the internet, but our interpersonal relationships are suffering and leading to disengaged communities. In this time of division and isolation we need to find new ways to connect locally. The acts of creative collaboration bring individuals and communities together and create dynamic places to live and work. Artwork within the Appalachian Mountains are helping communities to heal and thrive. The workshop will help people to see that their own struggles are the same as their neighbors. Even if they have nothing in common. It's not just the artists that are struggling making a living, it's all of us. If we learn to work together we can help one another. The Shift program encourages creatives. It takes creative people and encourages them to develop new and important roles within the community. The business people can expand their creative skills. We all learn to work together and find new solutions to the problems we have. When a Ridgeview teen works with an Air Shift project they will be able to document the opportunity on their college application for Virginia Tech or Berea and immediately be seen as a leader within their own community and as an individual that can lead as well as collaborate with others in order to accomplish great things. **Kathy Harrison** - (Gave out copies of facilities agreement) The handout is the first three pages of the facilities development agreement. This document was drafted by the attorneys for the School Board, the Board of Supervisors and the IDA. The agreement was followed for the consolidation of the three High Schools, the Middle School and the Technical School. Now it is time to follow it for the relocation replacement of Sandlick Elementary and Clinchco Elementary. On page two it reads: 8) It is the goal of the parties to construct educational facilities at locations that are reasonably centrally located to the children to be served by said facilities. A location in the Rose Ridge section of Dickenson County has been selected for the consolidated high school, middle school and career/technical school. A new elementary school will be located in an area yet to be determined in the area of Sandlick, Haysi or Clinchco.

The parties hereby acknowledge that contractual commitments have been made to third parties and funds have been paid to third parties based upon these locations and the parties hereto irrevocably commit that these locations shall be the location upon which the above referenced educational facilities shall be constructed. It is my opinion that with the Lawsuit that the School Board has brought they are trying to not follow the facilities development agreement for the construction of the Elementary School. I don't know of any other time you pick and choose which parts of a contract you want to follow. I think it needs to be followed for the rest of the way through. Remember the age groups when making decisions for the elementary relocation, remember the how geographically challenged our county is when getting students from point A to B. Our SOL's in our elementary school are very good. All elementary students take them. Third, fourth, and fifth are very good. These are the scores our High School is building on. These are the scores we need to pay attention to. Lets not forget foundation education is one of the most important things you have on your agenda.

**Carroll Edwards** - I would like to say that you have the power in your hands to move this school system forward or you can move it back. I think you will move it forward. I recommend that you dismiss the Lawsuit. It was a bad lawsuit that cost thousands and thousands of dollars in attorney fees and studies. I would like to suggest that you strongly consider the Backbone Ridge site. I feel that this board will take a good look at everything. It's about our kids, if they get a good education or not. That's what the school system is for. I urge you to move forward tonight.

**Rocky Barton** - I want to speak on the corp project and on the recent flooding. It's about the fifth time we dodged a bullet with flooding since the corp project. We have done a lot with our flood project. We had three and a third schools to flood proof. We flood-proofed Ervinton High School, Clinchco Elementary the buildings below the road at Haysi High School. Sandlick Elementary, the biggest school and the school that landed the money is still right in the middle of the Floodplain. I was on the original sight committee that picked Rose Ridge for Ridgeview the same sight committee picked Haysi for the Elementary School. The criteria we used was the bulk of the people. Rose Ridge was the population center of our county. But the same committee that picked the sight that we call Backbone Ridge. I don't know how the project became stalled. Attorneys stalled and stalled. We have the money to build our school, we have the sight. We can do a public /private partnership. Buchanan county just announced they are consolidating schools. If they build their school where they say they will it will be six miles from Haysi.

### DICKENSON COUNTY SUPERINTENDENT NAMED REGIONAL SUPERINTENDENT OF THE YEAR

*Richmond, Virginia* (February 25, 2020) - Ms. Haydee L. Robinson, Superintendent of Dickenson County Public Schools, was recently named Region VII Superintendent of the Year by her colleagues, who are the chief education leaders of the eighteen school divisions located in Southwest Virginia. Ms. Robinson was selected for her inspirational leadership among the members of the Region VII superintendents as well as for her accomplishments as Superintendent of Dickenson County Public Schools.

Ms. Robinson has been an active member of her professional organization, the Virginia Association of School Superintendents (VASS), as a member of the organization's Professional Learning Committee. As a representative of the committee she was instrumental in planning high quality professional development for all of the school division superintendents in the state. Ms. Robinson has also served on the VASS Legislative Committee.

As Superintendent of Dickenson County Schools, Ms. Robinson worked to find funding for new school construction through innovative approaches with the federal government that led to \$110 million for new school construction. Under her leadership all Dickenson County schools have become accredited and the school system has made significant improvements in its test scores and graduation rates along with significant reductions in chronic absenteeism and dropout rate.

Ms. Robinson will compete against other Regional Superintendents of the Year representing each of the eight regions in Virginia. The winner will be announced as the Virginia Superintendent of the Year on Monday, April 27 at the Annual Awards Luncheon of the Virginia Association of School Superintendents in Roanoke.

This opportunity has been made possible by generous donations from the Columbus Phipps Foundation and Contura.

### **f. Update on the New Elementary School**

Phone conference - PowerPoint presentation - Curtis Elswick construction project manager for the new elementary school. (attached) After much discussion a motion was made by Jason Hicks and a second by Jamie Hackney to resend the previous resolution passed on February 17, 2020 to the Board of Supervisors.

### **g. Update on the 2020 - 2021 State Budget**

As we reported last month, the Governor's Proposed FY-21 – FY-22 budget looks promising. It includes a 3% salary increase that is funded in FY-22. Also significant in the proposed budget is the approximately \$330,000 in additional funds we anticipate receiving for At-Risk funding for the upcoming year.

Last week, both the House and Senate completed their amendments to the Proposed FY-21 – FY-22 budget. It is very encouraging that both budgets include salary increases for SOQ instructional and support positions. The House Budget proposes a 2% increase for each year, FY-21 and FY-22. The Senate Budget proposes a one-time 3% bonus in FY-21 and a 4% salary increase in FY-22. Both Budgets still have additional funding for At-Risk, similar to the Governor's Proposed Budget. Although the Virginia Department of Education has not yet provided the Entitlement Sheets to us, both the House and Senate Budgets appear to be favorable at this time. We hope to have a finalized State budget sometime in March.

We have a Budget Workshop scheduled for March 4<sup>th</sup> to get feedback from the School Board on the budget and a Budget Hearing on March 18<sup>th</sup> for public input on the budget. We also plan to schedule Budget meetings with the Board of Supervisors in March. We will keep the Board informed of the process.

### **h. Update on the DCPS 2019 - 2020 School Calendar**

The 2019 - 2020 DCPS Calendar has Friday, Mar. 6 - Monday, Mar. 9 2020 as scheduled Spring Break days. As of Wednesday, Feb. 26, 2020, we have missed 10 days of school due to inclement weather.

Based on this information, we are recommending no changes to the Spring Break schedule to the School Board: Therefore, Dickenson County Schools will be closed on Friday, Mar. 6 - Monday, Mar. 9, 2020. We were scheduled for early dismissal on Thursday, Mar. 5, 2020, but will recommend that we attend school all day on Thursday, Mar. 5, 2020.

Several of have also asked about the Governor's State of Emergency Day for flooding which was called on Feb. 6, 2020, and whether this day will need to be made-up. We have not yet received any information regarding this issue, but will keep you informed of any further information.

In the event that more days are missed in March due to inclement weather we will then consider other alternatives for make-up days such as using one day for Easter Holidays, etc. We will also keep you informed of any changes to the calendar as soon as possible.

### **i. Discussion of DCPS 2020-2021 School Calendar**

Presented are three calendar options. The first two have school starting on Thursday, August 6th. Option 1 includes a long weekend for Spring Break in March and a long weekend for Easter Break in April. Option 2 combines both Spring and Easter Break together for Four days in April. Option 3 has school starting on Monday, August 10th, scheduling 88 days for the 1st semester, and planning a long weekend for Spring Break in March and a long weekend for Easter Break in April.

We are on a fine timeline right now that we may lose that and we may join the rest of the school systems being in that situation and that is something we need to avoid. I hope that by asking the Board of Supervisors out again that we can talk and begin to settle something. Once we start talking to one another I believe we can begin moving forward and see what our options are.

**Damon Rasnick** I would also like to congratulate our Superintendent. Being selected as Region Seven Superintendent is a big deal. We have had a lot of big deals in Dickenson County. Our kids and teachers and Staff have had scores that are phenomenal. Our schools have been recognized in every positive way that can be. I know how hearts feel about this new school. And I know this in the end, if we can't find some way to cooperate. If we can't find a way to make it fit in the money. When you sign that dotted line no matter what your heart tells me or head says when these construction people come with these recommendations, you see what is there. There is no changing the fact of the matter. Except it goes down eighty thousand dollars a month, if it goes out over twelve months that's over a million dollars just in that one year. I don't think the Corp is going to put up with this. That is my opinion. I think we're taking a high risk. I hope we can come together and do the right thing. It has to be within the money. There is nothing we can do about that. School Boards can not borrow money, School Boards can not tax. It comes out of the budget you put in place, this budget the corp put in place. If the Board of Supervisors can use that money for interim financing. I have complete faith in their attorney of thirty two years experience and our Superintendent of ten years in Dickenson County. I have faith that these people have led the other effort and can lead this effort in a manner that's the best we can do. I certainly look forward to working with everybody here to make that happen.
